The board of directors ("Board") of Harris County Water Control and Improvement District No. 113 ("District") met on November 9, 2021 at 12903 Cricket Hollow, Cypress, Texas, pursuant to the duly posted notice of said meeting with a quorum of directors present as follows:

Also, in attendance were Jennifer Day, Scott Shelnutt, Michelle Guerrero, Chris Burke and Lisa Stephens.

The President called the meeting to order at 7:12 p.m. and declared it open for such business as might properly come before it.

- 1. No members of the public were present for comments.
- 2. Minutes of the October 12, 2021 meeting were presented. Upon motion duly made by Director Maniscalco, seconded by Director McCorkle and unanimously carried, the minutes of said meeting were approved as presented.
- 3. Michelle Guerrero presented the tax assessor-collector's report which reflected the 2020 taxes collected at 98%. Ms. Guerrero advised the Board that statements for the 2021 taxes were mailed in October. After further discussion, upon motion duly made by Director Hoyland, seconded by Director Robicheaux and unanimously carried, the Board approved the tax assessor-collector's report and the checks drawn on the tax fund.
- 4. The Board then recognized Jennifer Day of McCall Gibson Swedlund & Barfoot PLLC, who presented a draft audit of the District for the fiscal year ending May 31, 2021. After discussions, upon motion duly made by Director Hoyland, seconded by Director McCorkle and unanimously carried, the Board approved the draft audit for the fiscal year ending May 31, 2021 as presented.
- 5. The Board considered a Resolution Affirming Review of Investment Policy, Strategies and Objectives. Director Hoyland made a motion to approve the resolution,

Director Maniscalco seconded the motion. With no opposition, the Board approved the attached Resolution Affirming Review of Investment Policy, Strategies and Objectives.

- 6. The Board next considered proposals for renewal of the District's insurance for the 2021 2022 term. After discussion, upon motion made by Director Hoyland, seconded by Director McCorkle and unanimously carried, the Board accepted the proposals as presented.
- 7. The Board considered the amendment to the District's Schedule of Fees and Rates for Water and Waste Collection and Disposal Service. After a brief discussion, the Board requested this matter be reviewed again at the December meeting.
- 8. Scott Shelnutt presented the operator's report. There were 420 total connections in the District. Collections for the month were at \$32,934.07 with current billings at \$30,089.63. The report showed water accountability was at 91.35% for the period ending October 14, 2021. The Board reviewed the delinquent list and requested the operator to proceed as necessary in accordance with the District's rate order. After further discussion, upon motion duly made by Director Hoyland, seconded by Director McCorkle and unanimously carried, the Board approved the operator's report as presented.
- 9. Chris Burke then presented the engineering report. Mr. Burke discussed Phase 7C and Phase 1C improvements at the Sanitary Sewer System. Mr. Burke reported that letters regarding discharge of grease into sanitary sewers had been mailed to the businesses at 12640 Telge Road (Telge Plaza). After further discussion, upon motion duly made by Director Hoyland, seconded by Director McCorkle and unanimously carried, the Board approved the engineering report as presented.
- 10. The Board then reviewed the bookkeeper's report. There was question as to check number 5739 in the amount of \$1,673.48 payable to Kleen Environmental. It was mentioned it may have been a refund. Mr. Burke advised he would follow up with the bookkeeper on this. Upon motion then duly made by Director Hoyland, seconded by Director Robicheaux and unanimously carried, the Board approved the attached bookkeeper's report and approved payment of the checks listed thereon.
- 11. With there being no further business to come before the Board, the meeting was adjourned at 7:57 p.m.
