

## NOTICE OF MEETING

### HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 500 (Master)

The Board of Directors of Harris County Municipal Utility District No. 500 will hold a regular Master District meeting on **Wednesday, November 3, 2021, at 12:00 p.m.**, at **The Lakehouse, 10000 Towne Lake Parkway, Cypress, Texas**, to discuss and, if appropriate, act upon the following items:

1. Public comments (3-minute limit).
2. Approve minutes.
3. Financial and bookkeeping matters, including payment of the bills, review of investments, collection of monthly charges for operation and maintenance, and fund transfers.
4. Contract Revenue Bonds (Park Facilities), Series 2021 ("Series 2021 Bonds"), including:
  - a. review bids and award sale of the District's \$11,680,000 Contract Revenue Bonds (Park Facilities), Series 2021;
  - b. adopt Resolution Authorizing the Issuance of the District's \$11,680,000 Contract Revenue Bonds (Park Facilities), Series 2021;
  - c. approve Paying Agent/Registrar Agreement;
  - d. approve Official Statement;
  - e. execution of Certificate Regarding Provision of Financial Advice;
  - f. authorize the Board of Directors to sign all documents relating to the bond sale and authorize attorney and financial advisor to take all necessary action to deliver bonds to the purchaser;
  - g. approve payment to Attorney General relating to bond issue transcript review; and
  - h. update from District engineer on Texas Commission on Environmental Quality inspection of facilities.
5. Operation of District facilities, including:
  - a. billings, repairs, maintenance;
  - b. update on replacement of lift pump nos. 1 and 2 at lift station no. 2, and water plant no. 2 fence rehabilitation project;
  - c. proposal for landscaping improvements and maintenance at wastewater treatment plant site; and
  - d. Assignment and Amendment of Operating Services Agreement.
6. Discuss lake management and maintenance, including:
  - a. wildlife management, including report and proposals from A All Animal Control;
  - b. erosion, dredging, and water quality, including report from Erosion Control Committee; and
  - c. amendments to lake rules, including request from Towne Lake Community Association and amendment to District lake rules.

7. First Amendment to Emergency Water Supply Agreement with Harris County Municipal Utility District No. 196.
8. Engineering matters, including:
  - a. grade separation at Union Pacific Railroad and intersection improvements at Highway 290, including:
    - i. preliminary engineering and Advance Funding Agreement with TxDOT, and consultant acquisition method required by TxDOT;
    - ii. update on Houston-Galveston Area Council Transportation Improvement Program participation;
    - iii. Interlocal Agreements with funding partners;
    - iv. project schedule; and
    - v. updated analysis of financial impact of project.
  - b. report on stormwater facilities maintenance and repairs, and approve Submerged Storm Sewer Agreements and Maintenance Agreements;
  - c. authorize design, approve plans and specifications, authorize advertisement for bids, and review bids and award construction contracts, including for the following construction projects:
    - i. emergency water interconnect with Harris County Municipal Utility District No. 196;
    - ii. water well no. 1;
    - iii. wastewater treatment plant no. 2;
    - iv. Mound Road east utility extension;
    - v. water plant no. 1 hydropneumatic tank addition; and
    - vi. wastewater treatment plant no. 1 generator.
  - d. approve pay estimates, change orders, substantial completion, final acceptance, termination, and/or settlement agreements, including for the following construction projects:
    - i. wastewater treatment plant aeration and digester basin rehabilitation;
    - ii. Towne Lake Section 60 temporary access road; and
    - iii. Detention 1L (Phase Two).
  - e. approve requests for capacity reservations and utility commitment letters; and
  - f. update on TPDES permit renewal application for Horsepen Creek Wastewater Treatment Plant.
9. Accept or grant conveyance of deeds, utility deeds, and easements, approve consents to encroachment, rights of entry, abandonments of easements and environmental proposals.
10. Surplus funds application for additional developer reimbursements and bond application no. 11.
11. West Harris County Regional Water Authority matters, including surface water delivery and construction of surface water line for water plant no. 2.

12. Landscape architect's report, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award construction contracts, approve pay estimates and change orders, substantial completion, final acceptance, termination, and/or settlement agreements, for landscaping/park facilities.
13. Report regarding development in the District.
14. Reports from District consultants regarding District correspondence and provision of records.
15. Discuss meeting schedule.
16. Review and revise action list.
