
2. There was no public comment.

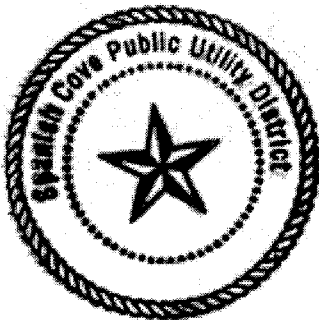


2. There was no public comment.

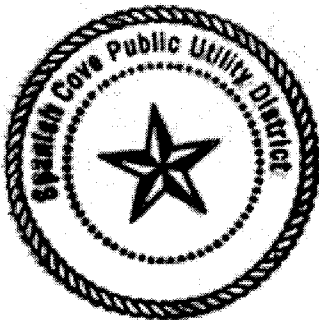
