NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 1400, Houston, Harris County, Texas, said address being an office and meeting place of the District.

The meeting will be held on **Monday, September 20, 2021, at 1:30 p.m.**

The Board shall consider and discuss the following matters and take any action necessary or appropriate with respect to such matters:


1. Public Comments;
2. Review and approve the minutes of the August 16, 2021 regular Board of Directors meeting;
3. Receive the Financial Advisor's recommendation concerning the District's proposed 2021 tax rate, determine intended tax rate, and authorize:
 - a) the required notice that the Board will consider adoption of a tax rate; and
 - b) the means of providing such notice;
4. Bookkeeper's Report, including payment of invoices presented;
5. Tax Assessor-Collector report, including:
 - a) Authorizing payment of invoices presented and approve moving of accounts to uncollectible roll;
6. Report and legal action taken by the District's delinquent tax collections attorney, including:
 - a) Appeals of termination of water service for delinquent tax accounts; and the taking of any action in connection therewith, including authorizing water termination, foreclosure proceedings, installment agreements, and the filing of proofs of claim;
7. Operations and Maintenance report, including:
 - a) Authorize repairs and maintenance of District facilities, and authorize acceptance of TEC Form 1295, as applicable;
 - b) Appeals of District charges;
 - c) Referral of accounts for collection and approve write-off of uncollectible accounts;
 - d) Communications with customers, including mass messaging; and
 - e) Implementation of H.B. 872 customer confidentiality requirements and authorize the giving of notice in connection with same;

8. Engineering report, including:
 - a) Authorizing the design and/or advertisement for bids for the construction of facilities within the District;
 - b) Authorize the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, and authorize acceptance of TEC Form 1295, as applicable, and approval of any related storm water permits;
 - c) Status of construction of facilities to serve land within the District, including the approval of any change orders, and authorize acceptance of TEC Form 1295, as applicable;
 - i. New Wastewater Treatment Plant and On-Site Lift Station Project (CSA Construction, Inc.);
 - d) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and authorize acceptance of TEC Form 1295, as applicable; and
 - e) Discussion regarding 2021 Sanitary Sewer Cleaning & Televising project;
9. Report from Champions Hydro-Lawn, Inc., including maintenance of detention facilities for the 4.66 acre Barker Cypress/FM 529, L.P. tract, the sites of the Wastewater Treatment Plant, Water Plant and Off-Site Lift Station, the Harris County Flood Control District channel, and the easements around Goo Goo Car Wash tract;
 - a) Status of renewal of Interlocal Mowing Reimbursement Agreement with Harris County Flood Control District for maintenance of drainage channel (Unit No. U118-00-00);
10. Discussion regarding surface water issues relative to the West Harris County Regional Water Authority;
11. Attorney's Report, including:
 - a) Status of prior Resolution Adopting Temporary Policies and Procedures in Response to Covid-19 Pandemic;
 - b) Approval of Order Establishing Office and Meeting Places Outside the District; and
 - c) Investigation into billings regarding joint Water Plant and Wastewater treatment Plant with Harris County Municipal Utility District No. 257;
12. Closed Session pursuant to Open Meetings Act, Texas Government Code, Section 551.071 to consult with the District's attorney regarding matters protected by attorney-client privilege;
13. Reconvene in Open Session and authorize any action resulting from matters discussed in Closed Session; and

14. Consideration of matters for possible placement on future agendas.
