Notice is hereby given to all interested members of the public that the Board of Directors ("Board") of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being an office and meeting place of the District.

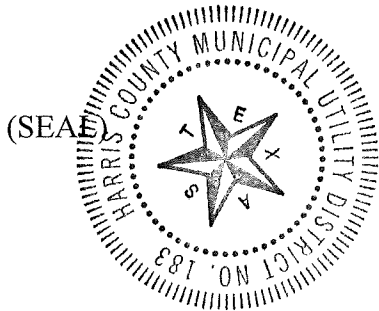
The meeting will be held on Tuesday, January 25, 2022 at 12:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public comments;
2. Review and approve the minutes of the Board of Directors meetings held on November 23, 2021 and December 28, 2021;
3. Discussion regarding appointment of a new Director to fill the vacancy on the Board;
4. Bookkeeper's Report, including (i) financial and investment reports, discussion regarding status of investment of District funds, authorizing the payment of invoices presented and authorizing any other actions necessary or appropriate in connection therewith, and (ii) amendment of the District's operating budget for fiscal year ending June 30, 2022;
5. Adoption of Resolution Adopting List of Qualified Brokers Authorized to Engage in Investment Transactions with District;
6. Tax Assessor-Collector's Report, including status of delinquent tax accounts, and authorizing payment of invoices presented and moving of accounts to uncollectible roll;
7. Grant exemptions from taxation for 2022, and the adoption of a Resolution in connection therewith;
8. Delinquent Tax Collections Attorney, including review of Report and authorizing foreclosure proceedings, installment payment agreements, the filing of proofs of claim, and termination of water service, if appropriate;
9. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Personal Property Taxes and authorize delinquent tax attorney to collect delinquent personal property taxes beginning April 1, 2022, including the filing of lawsuits, as necessary;

10. Engineer's Report, including:
 - a) Authorizing the design and/or advertisement for bids for the construction of facilities within the District and approval of related storm water plans;
 - b) Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities to serve land within the District, approval of any related storm water permits, and authorize acceptance of Texas Ethics Commission ("TEC") Form 1295;
 - c) Status of construction of facilities to serve land within the District, and approval of any change orders, and authorize acceptance of TEC Form 1295 in connection therewith;
 - d) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes;
 - e) Bond Application Report No. 8;
 - f) Annual Water Plant Inspection;
 - g) Annexation Feasibility Study;
 - h) Water Plant and Remote Well Security Improvements;
 - i) Fuel tank at Water Plant No. 1, including Resolution Authorizing Use of Surplus Funds and Interest Earned on Construction Funds; and
 - j) Discussion regarding the District's Emergency Preparedness Plan and Emergency Communication Plan;
11. Issuance of utility commitments;
12. Operations and Maintenance Report, including:
 - a) Repair and maintenance of facilities;
 - b) Written appeals of District charges;
 - c) Referral of accounts for collection and approve write-off of uncollectible accounts;
 - d) Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same; and
 - e) Status of fiber-optic cable installation within the District and potential damage to District facilities;
13. Authorize operator to provide required information to districts receiving water from the District relative to Consumer Confidence Reports;
14. Security Report, including report from Harris County Sheriff's Office;
15. Approval of Interlocal Agreement for Law Enforcement Services between the District and Harris County;
16. Proposed administrative building, including (i) review and approval of Contract between the District and Martinez Architects for architectural design services; and (ii) discussion regarding architectural design and construction subcommittees;

17. Convene executive session pursuant to Open Meetings Act, Texas Government Code Section 551.071 (consultation with attorney), and/or Section 551.072 (acquisition of real property or interests therein);
18. Reconvene in open session; authorize the taking of any action resulting from deliberations in executive session;
19. Authorize preparation and submission of District information to Texas Comptroller of Public Accounts as required by Section 403.0241, Texas Government Code, and Chapter 203, Texas Local Government Code, for inclusion in the Special Purpose District Public Information Database;
20. Discussion of renewal of District insurance coverages and authorize solicitation of proposals for same;
21. Supplemental Agenda in English, Spanish, Vietnamese and Chinese regarding calling Directors Election;
22. Attorney's Report; and
23. Matters for possible placement on future agendas.

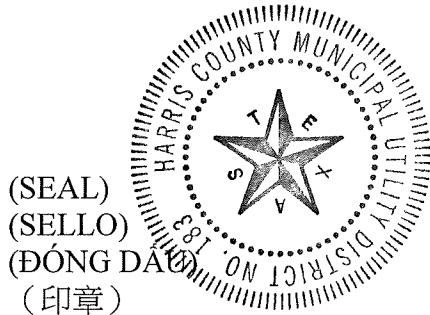
