  - c. deeds and easements and related environmental assessment proposals, consents to encroachment and encroachment agreements, requests for service, or utility commitment letters; and
  - d. Emergency Water Interconnect and related Agreement with Fort Bend Municipal Utility District No. 30.
13. Series 2022 Unlimited Tax Bonds, including:

- a. approve of Preliminary Official Statement and Official Notice of Sale;
  - b. engage rating company to perform credit rating analysis for Series 2022 Unlimited Tax Bonds;
  - c. appoint Paying Agent/Registrar;
  - d. authorize advertisement for sale of the Series 2022 Bonds and schedule bond sale;
  - e. authorize auditor to prepare developer reimbursement report;
  - f. Authorize District engineer to request Texas Commission on Environmental Quality inspection of facilities; and
  - g. authorize tax assessor/collector to request Certificate of Assessed Value as of January 1 from the Appraisal District.


