
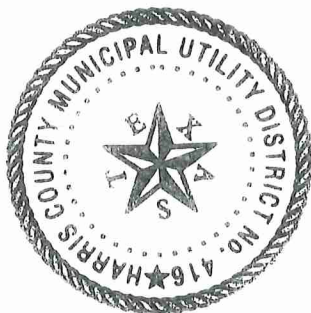
### NOTICE OF PUBLIC MEETING

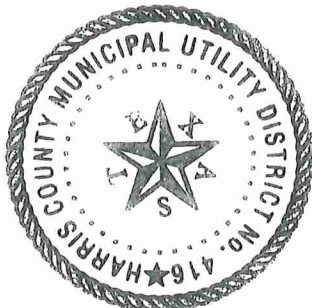
