and all of the above were present except Director Hupp, thus constituting a quorum.

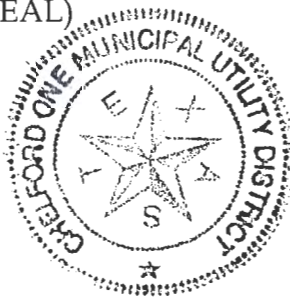
Also present at the meeting were those persons listed on the attached attendance sheet.
