  - a. modification of trail lights; and
  - b. camera installation matters.

  - a. approve and distribute Certificates of Election; and
  - b. approve Directors' Sworn Statements and Oaths of Office.
14. Reorganize Board and elect officers.
15. Authorize filing of District Registration Form with Texas Commission on Environmental Quality.


