Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a regular public meeting at 17707 Old Louetta Road, Spring, Texas 77070, said address being a meeting place of the District.

The meeting will be held on Wednesday, June 22, 2022, at 7:00 p.m.

The Board shall consider and discuss the following matters and take any action necessary or appropriate with respect to such matters:

- 2. Approve the minutes of the Board of Directors meetings held on May 25, 2022 and June 8, 2022;
