1. Questions and comments from residents and participants in the Chelford City Regional Wastewater Treatment Facility (the "Plant");

 - (b) status of the Wi-Fi system for the Plant's SCADA system (Fitch Services, Inc.);
 - (c) status of replacement of non-potable water system at the Plant (C3 Constructors, LLC);
 - (d) status of waste activated sludge pump (Sustanite Support Services, LLC);

 - (f) discuss status of City of Houston participation in the Plant;
 - (g) discuss proposed electrical conversion and P/D blower upgrade;
