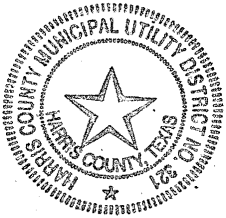
HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 321

The Board of Directors of Harris County Municipal Utility District No. 321 will hold a regular meeting on Tuesday, August 16, 2022, at 11:00 a.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Trinity Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes of prior meetings.
3. Approve developer reimbursement report for Series 2022 Unlimited Tax Park Bonds and authorize disbursement of bond proceeds.
4. Financial and bookkeeping matters, including payment of the bills, review of investments, depository pledge agreements, and amendment of budget, if necessary.
5. Adopt budget for fiscal year end September 30, 2023.
6. Review joint facilities budget for fiscal year end September 30, 2023.
7. Tax assessment and collections matters, including delinquent tax collections, installment agreements, payment of tax bills, and requests for estimates of taxable value.
8. Operation of District facilities, including billings, repairs, maintenance, and amendment of Rate Order, if appropriate.
9. Hearing on termination of water and sewer service to delinquent customers and for damages or theft of District facilities or services and authorize termination of service.
10. City of Houston industrial user permitting matters.
11. Review and discuss Drought Contingency Plan and take action related to same, if necessary; adopt Order Adopting Amended and Restated Drought Contingency Plan, if necessary.
12. Maintenance of detention ponds and District facility sites, including proposals for additional work.
13. Development matters.
14. Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
 - a. traffic signal at Greens Crossing Boulevard and Fallbrook Drive;
 - b. drainage and paving for Fallbrook Drive Street Dedication Section 2;
 - c. lift station no. 1 rehabilitation;
