NOTICE OF PUBLIC MEETING



The public is invited to attend at that location, where a quorum of the Board of Directors will be present. A member of the Board of Directors present at that location will preside over the meeting. **Members of the public may also access the meeting by following the instructions listed at the bottom of this notice.**

The meeting will be held at **10:00 a.m. on Thursday, October 13, 2022.**

The subject of the meeting is to consider and act on the following:

1. Public comment
2. Approve minutes of September 8, 2022 meeting
3. Tax assessor-collector's report; status of tax collections
4. Public hearing on proposed 2022 tax rate; Order Setting Tax Rate, Approving Tax Roll, Levying Debt Service Tax and Maintenance and Operation Tax for the Year 2022; Amendment to Statement of Directors and other filings after setting 2022 tax rate
5. Delinquent taxes; authorize termination of water service as appropriate; authorize litigation and installment agreements
6. Operator's report; customer correspondence; status of operation of District facilities; repairs and maintenance of District facilities, termination of service to delinquent accounts; Drought contingency plan
7. Amend operator's contract for fuel surcharge
8. Detention pond operations report; authorize pond repairs and maintenance
9. Engineer's report; authorize preparation of plans as appropriate; authorize advertising for receipt of bids as appropriate; award contracts; approve change orders
10. Bookkeeper's report; pay bills and investment of District funds
11. Engage auditor for fiscal year ending September 30, 2022
12. Accept resignation of director, if applicable; Appointment of director to fill vacancy
