4. Tax assessment and collection matters, including delinquent tax collections, payment of tax bills, and estimate of value, as appropriate.

  - a. review and discuss Drought Contingency Plan and take action related to same, if necessary; adopt Order Adopting Amended and Restated Drought Contingency Plan, if necessary; and
  - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
6. Storm water facilities maintenance and operations, including:
  - a. Focal Point Basin Maintenance;
  - b. Detention Pond/Drainage Swale Maintenance; and
  - c. proposals for additional maintenance work.

Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
  - a. Wastewater Treatment Plant Phase 2;
  - b. Phase II MS4 Storm Water Management Plan;
  - c. deeds and easements and related environmental assessment proposals, consents to encroachment and encroachment agreements, requests for service, or utility commitment letters;
  - d. Emergency Water Interconnect and related Agreement with Fort Bend Municipal Utility District No. 30;
  - e. Water Plant Treatment Modifications; and
  - f. update on bond application no. 4.
