
NOTICE OF MEETING

MISSION BEND MUNICIPAL UTILITY DISTRICT NO. 2

The Board of Directors of Mission Bend Municipal Utility District No. 2 will hold a regular meeting on **Tuesday, February 21, 2023, at 6:00 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, in the Guadalupe Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

- 1. Public comments.
- 2. Approve minutes of prior meetings, including January 17 (Regular), January 30 (Integrated), February 7 (Greenbelt), and February 13 (Chelford), 2022.
- 3. Security services matters, including:
 - a. report from Harris County Sheriff's Office; and
 - b. update on the implementation of signs prohibiting commercial vehicles from parking overnight.
- 4. Financial and bookkeeping matters, including payment of the bills and review of investments.
- 5. Discuss Association of Water Board Directors winter conference, approve reimbursement of eligible expenses, and authorize attendance at summer conference.
- 6. Accept proposal for workers compensation insurance.
- 7. Approve Annual Report and authorize filing of same in accordance with the District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
- 8. Annual Review of Procedures for Continuing Disclosure Compliance.
- 9. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
- 10. Adopt Resolution Concerning Exemptions from Taxation.
- 11. Chelford City Regional Wastewater Treatment Plant matters.
- 12. Operation of District facilities, billings, repairs and maintenance, and related operating matters, including the following:
 - a. hearing on termination of water and sewer service;
 - b. update on televising of facilities in Altamira, Section 1;
 - c. update on automated meter trial program;
 - d. Mission Bend Integrated Water System operating matters; and
 - e. authorize assessment of penalties for Rate Order violations.
- 13. Resolution Approving Submittal of the Water Smart Application for Inclusion in the Association of Water Board Directors Water Smart Partners Program.
- 14. West Harris County Regional Water Authority matters.
- 15. Engineering matters, including:
 - a. update on design of permanent generators;
 - b. update on sanitary sewer cleaning and televising project;

- c. update on recoating of ground storage tank no. 1 and no. 2 at water plant no. 2;
- d. phosphate addition at water well no. 1 at water plant no. 1; and
- e. requests for service or utility commitment letters.
- 16. Park and recreational facility matters, including proposals, agreements and amendments related thereto, pay estimates, change orders, and final acceptance, if appropriate, for the following:
 - a. Magnolia Park maintenance, including:
 - i. update on pressure washing;
 - ii. update on lighting maintenance and repair;
 - iii. update on repair of sidewalks with differential settling; and
 - iv. update on Phase III improvements.
 - b. Mission Bend Greenbelt Trail improvements project, including:
 - i. update on Trail Improvement contract punchlist items; and
 - ii. update on west side Trail expansion project.
 - c. Little Villa Wetland improvement project, including:
 - i. update on screen planting and irrigation improvements; and
 - ii. update on design and installation of western park boundary fence.
 - d. update on bond application no. 11, including adopt Resolution Requesting Appraisal of Property and Certificate of Estimated Appraised Value.

- 18. District technology matters, including update on transition of website hosting services and emergency notification services.
