13. Chelford City Regional Wastewater Treatment Plant matters.
14. West Harris County Regional Water Authority matters.
15. Mission Bend Greenbelt Association matters.
16. Report on the Greater Mission Bend Area Council.
17. Renewal of District's insurance policies.
18. Financial and bookkeeping matters, including payment of the bills and review financial agreements and take appropriate action.

19. Approve Annual Report and authorize filing of same in accordance with the District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
20. Annual Review of Procedures for Continuing Disclosure Compliance.
