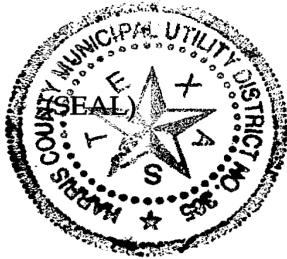
**CONSENT AGENDA:** The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event, the item will be removed and placed on the Regular Agenda.


1. Approve minutes.
2. Financial and bookkeeping matters, including payment of the bills, review of investments.
3. Tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills.
4. Operator's report of District water, sanitary sewer, and stormwater facilities, including billings, and repairs and maintenance.

    - i. Water Well No. 2 rehabilitation project;
    - ii. drainage channel repairs;
  - c. review bids and award contracts;

- d. approve pay estimates, change orders, and final acceptance, as appropriate, for construction projects, including:
    - i. water plant coating project.
  - e. reclaimed water system;
  - f. proposal for inspection and maintenance of cathodic protection system at Water Well No. 2;
  - g. deeds, easements, and encroachments;
  - h. unauthorized outfall;
  - i. update on bond application no. 5;
  - j. approve new rates under Engineering Services Agreement; and
  - k. other engineering matters.
- 11. Nonpotable water system matters, including Resolution Adopting Policy Regarding Non-Potable Water Use, and Nonpotable Water User Agreement.
  - 12. Public communications and community outreach events.
  - 13. Authorize submittal of request to the Region 6 San Jacinto Regional Flood Planning Group to include proposed District drainage project in the Amended Regional Flood Plan.
