

NOTICE OF MEETING

RENN ROAD MUNICIPAL UTILITY DISTRICT OF HARRIS AND FORT BEND COUNTIES, TEXAS

The Board of Directors of Renn Road Municipal Utility District of Harris and Fort Bend Counties, Texas, will hold a regular meeting on **Friday, March 3, 2023, at 11:30 a.m.**, at the offices of Vogler & Spencer Engineering, Inc., 777 North Eldridge Parkway, Suite 500, Conference Room A, Houston, Texas, to discuss and, if appropriate, act upon the following items:

3. Update on Kings Point Homeowners Association's community fence improvement project, review bids, consider maintenance and ownership agreement, and authorize appropriate action.
4. Garbage collection and recycling matters.
5. Security and patrol matters, including financial contributions for security services from District Homeowners Associations, and discuss security upgrades and recommendations.
6. Report on mowing and detention pond maintenance and authorization of work orders and proposals, as appropriate, and graffiti removal matters.
7. Renewal of District's insurance policies.
8. Financial and bookkeeping matters, payment of the bills, amend budget, and review of investments.
9. Tax assessment and collections matters, including delinquent tax collections, installment agreements, payment of tax bills, and delinquent tax report.
10. Review Critical Load Spreadsheet for District's facilities and authorize annual filing.
11. Conduct Annual Review of Drought Contingency Plan.
12. Review Emergency Preparedness Plan and authorize filing of updates, if necessary.
13. Operation of District facilities, billings, repairs and maintenance, including hearing on termination of water and sewer service to delinquent customers, authorize termination of service, and amendment of Rate Order, if applicable.
14. Engineering matters, including:
 - a. update on West Harris County Regional Water Authority matters;
 - b. wastewater treatment plant facilities, repairs, clarifier rehabilitation project, and permit renewals;
 - c. Fort Bend and Harris County mobility projects;

- d. deeds, easements, consents to encroachment, requests for service or utility capacity commitment letters, and development financing agreements; and
- e. other engineering matters, including:
 - i. discuss geographic information system (GIS) application proposal;
 - ii. update on Van Learning Academy;
 - iii. update on Capital Improvement Plan;
 - iv. update on Ground Storage Tank Rehabilitation project;
 - v. Kingspoint Sections 1-3 Sanitary Sewer Clean and Televisе project; and
 - vi. Eldridge Park matters.
- 15. Approve Annual Report and authorizing filing of same in accordance with the District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
- 16. Annual Review of Procedures for Continuing Disclosure Compliance.
- 17. Annexation matters, including annexation requests, letter agreements and annexation feasibility report.
- 18. Storm water management plan, storm water permitting matters; receive public comment, training, and authorize appropriate action.
