
1. Public comments.
2. Approve minutes of prior meeting(s).
3. Financial and bookkeeping matters, including payment of the bills, review of budget, and review of investments.
4. Tax assessment and collection matters, including delinquent tax collections, payment of tax bills, and estimate of value, as appropriate.
5. Operation of District facilities, including:
  - a. hearing on termination of water and sewer service to delinquent customers and authorize termination of service; and
  - b. conduct annual review and receive report from operator on Identity Theft Prevention Program and adopt Identity Theft Prevention Program Amendment.
6. Storm water facilities maintenance and operations, including:
  - a. Focal Point Basin Maintenance;
  - b. Detention Pond/Drainage Swale Maintenance; and
  - c. proposals for additional maintenance work.
7. Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
  - a. Phase II MS4 Storm Water Management Plan;
  - b. deeds and easements and related environmental assessment proposals, consents to encroachment and encroachment agreements, requests for service, or utility commitment letters;
  - c. Emergency Water Interconnect and related Agreement with Fort Bend Municipal Utility District No. 30; and
  - d. Water Plant Treatment Modifications.
8. Series 2023 Unlimited Tax Bonds, including:
  - a. review bids and award sale of the District's \$6,500,000 Unlimited Tax Bonds, Series 2023;
  - b. adopt Resolution Authorizing the Issuance of the District's \$6,500,000 Unlimited Tax Bonds, Series 2023;
