3. Series 2023 Unlimited Tax Bonds, \$4,475,000, including:
 - a. review bids and award sale of the District's \$4,475,000 Unlimited Tax Bonds, Series 2023;
 - b. adopt Resolution Authorizing the Issuance of the District's \$4,475,000 Unlimited Tax Bonds, Series 2023;
 - c. approve Paying Agent/Registrar Agreement;
 - d. approve Official Statement;
 - e. execution of Certificate Regarding Provision of Financial Advice;
 - f. authorize the Board of Directors to sign all documents relating to the bond sale and authorize attorney and financial advisor to take all necessary action to deliver bonds to the purchaser;
 - g. approve payment to Attorney General relating to bond issue transcript review; and
 - h. execution of Amendment to Information Form.
4. Financial and bookkeeping matters, including payment of the bills, review of investments, and amendment of budget, if necessary.
5. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
6. Detention pond and outfall channel facilities report, including review proposals and authorize appropriate action.
7. Update on MS4 storm water management matters, including application for waiver of coverage under TPDES General Permit No. TXR040000.

 - b. approve plans and specifications and authorize advertisement for bids for District facilities;
 - i. Sunset Grove Section 5; and
 - ii. Trails at Woodhaven Lakes Section 2;
 - iii. Mass Excavation and Grading for Trails at Woodhaven Lakes Section 2; and
 - iv. Clearing and Grubbing for Trails at Woodhaven Lakes Section 2;
