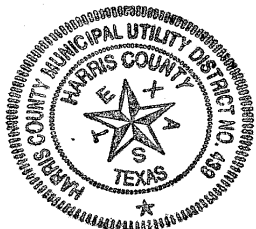


NOTICE OF MEETING
