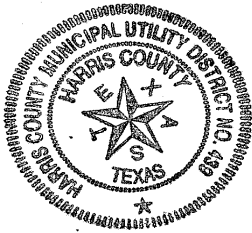



NOTICE OF MEETING
