**NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at **1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas**, said address being an office and meeting place of the District. Said meeting will also be conducted **via videoconference** and **telephone conference call** pursuant to Texas Government Code, Sections 551.125 and 551.127, as amended, respectively. **To join the meeting by videoconference, please go to <https://meet.goto.com/869117573>**. The meeting will be held on **Wednesday, June 14, 2023, at 8:30 a.m.**

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Comments from the public;
2. Review and approval of the minutes of the Board of Directors meetings held April 26, 2023 and May 10, 2023;
3. Bookkeeper's Report, including financial and monthly investment reports, and authorizing the payment of invoices presented;
4. Approval of Unclaimed Property Report(s) as of March 1, 2023, and authorize consultants to file Report(s) with State Comptroller prior to July 1, 2023;
5. Adoption of Resolution Adopting List of Qualified Brokers Authorized to Engage in Investment Transactions with the District;
6. Status of completion and filing of annual Continuing Disclosure Report (due June 30, 2023);
7. Tax Assessor/Collector's Report, including authorizing the payment of invoices presented; status of delinquent taxes and installment payment agreements; authorize moving of accounts to uncollectible roll;
8. Delinquent Tax Collections Attorney's Report, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim as necessary;
9. Operator's Report, including:
  - a) Appeals of District charges;
  - b) Referral of accounts for collection and approve write-off of uncollectible accounts;
  - c) Authorizing the repair and maintenance of District facilities, including:

- (i) Status of insurance claim related to repair of damages to Storm Water Pump Station located at Spring Plaza Regional Detention Pond; and
    - (ii) Status of sanitary sewer and manhole repairs recommended in connection with Sanitary Sewer Cleaning, Televising and Smoke Testing, Phase II;
  - d) Status of billing and collection of operations and maintenance costs related to Spring Plaza Regional Detention Pond and Storm Water Pump Station and Spring Pines Detention Pond; authorize any action necessary in connection therewith;
  - e) Discussion regarding status of compliance with backflow prevention device requirements, including status of repairs by Environmental Development Partners of same; authorize termination of services, if necessary; and
  - f) Status of investigation into low water accountability; authorize any action required in connection therewith;
10. Submission of updated contact information and/or descriptive information regarding District facilities that qualify for critical load status to the County Office of Emergency Management, Public Utility Commission, and the Division of Emergency Management of the Governor, relative to compliance with §13.1396, Texas Water Code;
11. Discussion regarding existing and potential tax-exempt multi-family developments within the District; authorize any action necessary in connection therewith;
12. Review and approval of Amended and Restated Construction and Maintenance Agreement between the District and Hannover Forest Homeowners Association;
13. Engineer's Report, including:
- a) Authorizing the design and/or advertisement for bids for the construction of facilities within the District, and approving of related storm water plans, including:
    - (i) Review and approval of any Storm Water Pollution Prevention Plans or Storm Water Quality Management Plans related to construction within or on behalf of District, and the execution of any documentation in connection therewith;
    - (ii) Modifications to Lift Station No. 1 (Louetta Woods);
    - (iii) Proposed extension of water and sanitary sewer lines along Holzwarth Road; and
    - (iv) Proposed construction of public gravity sanitary sewer line to serve tract located at 2020 FM 2920 (Top Soap);
  - b) Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, approval of any related storm water permits, and authorize acceptance of TEC Form 1295, including:
    - (i) Extension of 8-inch water line and 8-inch sanitary sewer line to serve property located at 1731 Spring Cypress Road (Starbucks); and
    - (ii) Review of proposals for replacement of drainage outfall pipes;
  - c) Status of construction of facilities to serve land within the District, including the approval of any change orders or pay estimates and authorize the

acceptance of TEC Form 1295, including:

- (i) Contract with CSE W-Industries, Inc. for Replacement and Installation of Emergency Generator at Water Plant No. 1 ("WP No. 1"); and
  - (ii) Contract between SC2 and Harris County Water Control and Improvement District No. 110 for construction of Emergency Interconnect;
- d) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes;
  - e) Review of District's updated water and wastewater capacity allocation chart;
