Engineering matters, including authorize design, approve plans and specifications, authorize advertisement or solicitation of bids, review bids and award contracts, approve letter financing agreements, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
 - a. surface water, chloramine conversion, and bleach disinfection conversion;
 - b. FM 1960 lift station no. 5;
 - c. FM 1960 water and sanitary sewer extension;
 - d. Cypress North Houston Road (LouEdd Road) widening;
 - e. Woodedge Village sanitary sewer rehabilitation;
 - f. feasibility studies, plan reviews, and utility availability requests;
 - g. Cypress Glen sanitary sewer repair project;
