4. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.

 - b. approve plans and specifications and authorize advertisement for bids for District facilities;
 - i. Sunset Grove Section 5;
 - ii. Trails at Woodhaven Lakes Section 2; and
 - iii. Mass Excavation and Grading and Clearing and Grubbing for Trails at Woodhaven Lakes Section 2;
 - c. review bids and award contract for construction in the service area, including updates on construction of facilities to serve development in the District;
 - i. Sunset Grove Section 6 water, sewer and drainage;
 - d. approve pay estimates, time extensions, change orders, and final acceptance, as appropriate for construction of District facilities, including:
 - i. Ambrose, Section 2 water, sewer and drainage; and
 - ii. Punch List Items for Sunset Grove Section 3; and
 - e. deeds, easements, plats, consents to encroachment, requests for service or utility commitment letters.
9. Report regarding development in the District.
