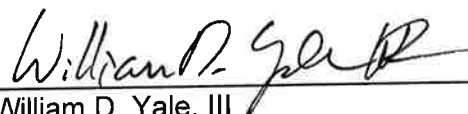

Notice is hereby given that the Board of Directors of Chelford City Municipal Utility District will hold a regular meeting, open to the public, on **MONDAY, 11 SEPTEMBER 2023, at 6:30 p.m.**, at the Chelford City Regional Wastewater Treatment Facility Administration and Maintenance Building, **15027 Alief Clodine Road, Harris County, Texas 77083**, outside the boundaries of the District. **Guests attending the meeting via teleconference, please dial 877-746-4263 and enter Guest Code 2222964.** The Board will consider and act upon the following matters:

1. Questions and comments from residents and participants in the Chelford City Regional Wastewater Treatment Facility (the "Plant");
2. Approval of the minutes of the meeting of 14 August 2023;
3. Operator's Report, including:
  - (a) status of operations at the Plant;
  - (b) review of maintenance list;
  - (c) status of work approved for the Plant;
  - (d) status of insurance claims and payments;
  - (e) report on vibration analysis of equipment at the Plant;
  - (f) review of billing to the Plant;
  - (g) review connection count for the Plant;
4. Bookkeeper's Report for the Plant, including:
  - (a) authorize payment of the bills of the Plant;
  - (b) review of income report for the Plant;
  - (c) review investments and authorize actions deemed necessary;
  - (d) review recap of Accounts Receivable and revise as needed;
  - (e) amend Operating Budget for fiscal year ending 9/30/23, as needed;
  - (f) adopt Operating Budget for fiscal year ending 9/30/24;
5. Report on testing and analyses at the Plant, including the results of monitoring in the collection system and the status of biomonitoring at the Plant;
6. Engineer's Report, including:
  - (a) review of issues related to the Mission Bend Integrated Water System (the "Integrated Water System");
  - (b) status of rotary drum screen replacement (Gilleland Smith Construction, Inc.);

- (c) status of Headworks "A" washer compactor replacement (Gilleland Smith Construction, Inc.);
  - (d) status of digester blower No. 1 replacement (C3 Constructors LLC), including proposal for maintenance service and warranty (Vision Equipment);
  - (e) status of sludge horizontal screw conveyors (C3 Constructors LLC);
  - (f) status of air conditioner upgrade in operator room (GH Mechanical & Services, LLC);
  - (g) status of pressure tank for NPW system (Sustanite Support Services, LLC);
  - (h) discuss status of thickener (odor reduction);
  - (i) status of electrical conversion (4160V to 480V) for P/D Blower Replacement (Clarion Electrical, LLC);
  - (j) review proposals for replacement of turbo blowers;
  - (k) review of the Five-Year Plan for the Plant;
  - (l) discuss status of City of Houston participation in the Plant;
  - (m) review status of warranties for completed projects;
  - (n) discuss pending items and authorize actions deemed necessary;
