NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular meeting at **1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas**, said address being a meeting place of the District.

The meeting will be held on Friday, October 20, 2023, at 12:00 Noon.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:


1. Public Comments;
2. Approval of minutes of the September 15, 2023, Board of Directors meeting;
3. Tax Assessor-Collector Report, including reviewing the status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds, and approving moving of accounts to the uncollectible roll;
4. Report and legal action taken by the District's delinquent tax collections attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
5. Conduct a public hearing regarding the adoption of the District's 2023 tax rate;
6. Levy of the District's 2023 debt service and maintenance tax rates, and the adoption of an Order in connection therewith;
7. Approval and execution of an Amended District Information Form;
8. Bookkeeper's Report, including financial and investment reports, including authorizing the payment of invoices presented;
9. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting;
10. Annual review of Amended Order Establishing Policy for Investment of District Funds and Appointing Investment Officer, and adoption of Resolution and amended Order in connection therewith;
11. Engineer's Report, including:
 - (i) Authorizing the design and/or advertisement for bids for the construction of facilities within the District, authorizing acceptance of TEC Form 1295, and approving of related storm water plans, including:
 - (a) Review and approval of any Storm Water Pollution Prevention Plans or Storm Water Quality Management Plans related to construction within

- or on behalf of the District, and the execution of any documentation in connection therewith;
 - (ii) Award of construction contracts or concurrence of award of contracts for construction of facilities within the District, and acceptance of TEC Form 1295, and approval of any related storm water permits;
 - (iii) Status of construction of facilities to serve land within the District, including the approval of any change orders, and authorize acceptance of TEC Form 1295, as applicable;
 - (a) New Wastewater Treatment Plant (R&B Group, Inc.) (District Project);
 - (iv) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes;
 - (v) Status of street and storm sewer acceptance by Harris County; and
 - (vi) Discussion regarding proposed installation of permanent fence at Wastewater Treatment Plant site;
- 12. Issuance of utility commitment(s);
- 13. Detention and Drainage Facilities report (Storm Maintenance and Monitoring, Inc.);
- 14. Operator's Report, including;
 - (i) Repair and maintenance of facilities;
 - (ii) Compliance with permits;
 - (iii) Appeals of District charges; and
 - (iv) Refer accounts for collection and write-off of uncollectible accounts;
- 15. Report by Republic Services, Inc. ("Republic") concerning solid waste collection and recycling activities within the District; approval of Customer Service Agreement between the District and Republic regarding servicing of dumpster located at the Wastewater Treatment Plant;

- 17. Discuss options for reimbursement of Blusky Interests, Ltd. and authorize any action in connection therewith, including use of surplus operating funds; adoption of resolution regarding same; engage auditor to prepare developer reimbursement audit report;

 - (i) Discussion regarding establishment of a website for the District, or other alternative;
- 19. Closed Session pursuant to Open Meetings Act, Texas Government Code, Section 551.071 to consult with the District's attorney regarding matters protected by attorney-client privilege;
