10. Chelford City Regional Wastewater Treatment Plant matters.
11. West Harris County Regional Water Authority matters.
12. Mission Bend Greenbelt Association matters.
13. Report on the Greater Mission Bend Area Council.
14. Financial and bookkeeping matters, including payment of the bills.
15. Conduct annual review of Investment Policy and adopt Resolution Regarding Annual Review of Investment Policy.
16. Review, revise, and adopt Resolution Establishing the Authorized Depository Institutions and Adopting List of Qualified Broker/Dealers with Whom the District May Engage in Investment Transactions.
