- Tax Assessor/Collector's Report, including:
 - a. Approval of Tax Report and payment of tax-related checks; and

 - g. Rule 15c2-12 Certificate;

 - i. Take such other actions and execute such other documents and certificates necessary to obtain approval of the Bonds by the Attorney General.

 - a. Consider approving any requests for water and sewer commitments;
 - b. Report on surface water issues and take necessary action related thereto;
 - c. Report on operations of District plants and authorize necessary repairs and maintenance;
 - d. Consider and approve pay applications and change orders to existing contracts;
 - e. Authorize advertisement for bids for District construction projects;

 - g. Discuss proposed water well locations and consider entering closed session under Government Code, Chapter 551.072.
