Minutes of Meeting of Board of Directors October 26, 2023

The Board of Directors ("Board") of Harris County Municipal Utility District No. 416 ("District") met at 2727 Allen Parkway, Suite 1100, Houston, Texas 77019, in accordance with the duly posted notice of the meeting, with a quorum of directors present as follows:

The Vice President called the meeting to order and declared it open for such business as might properly come before it.

- 1. The Board opened the meeting for public comment. Hearing none, the Vice President continued with the agenda.
- 2. The Board considered the minutes of the meeting held September 14, 2023. Upon motion duly made, seconded, and unanimously carried, the Board approved the minutes as presented.
- 3. The Board recognized Ms. Tina Tran who presented the bookkeeper's report. The Board reviewed mowing and maintenance expenses. Upon motion duly made, seconded, and unanimously carried, the Board approved the bookkeeper's report, authorized payment of the checks listed thereon.
- 4. The Board then recognized Ms. Suzanne Villarreal who presented the audit report for the fiscal year ended June 30, 2023. The Board reviewed the report, including the management discussion and analysis, and also reviewed a management letter prepared by the auditor. After discussion, upon unanimous vote, the Board approved the audit report and authorized the attorney to file the report with the required audit filing affidavit as required by law.
- 5. The Board then considered the Resolution Affirming Review of Investment Policy, Strategies, and Objectives. The District's auditor and attorney informed the Board that the policy has been reviewed and that no changes are necessary at this time. Upon

motion duly made, seconded, and unanimously carried, the Board approved the Resolution as presented.

- 6. The Board then considered the District's continuing disclosure obligations. Upon motion duly made, seconded, and unanimously carried, the Board authorized the attorney to file the District's continuing disclosure.
- 7. The Board recognized Brenda McLaughlin who presented the tax assessor-collector's report. The 2022 taxes are 98.45% collected. The Board reviewed and discussed the District's delinquent accounts in detail. Upon motion duly made, seconded, and unanimously carried, the Board approved the report as presented.
- 8. The Board then confirmed the publication of notice of the District's intent to hold a public hearing and set the 2023 tax rate at this meeting. Accordingly, the Board opened a public hearing on the District's proposed 2023 tax rate. It appeared that the Harris County Appraisal District had heretofore prepared and certified to the District's tax assessor-collector the final 2023 appraisal roll of the District. The Board then discussed the tax rate. The public hearing was then closed.
- 9. The Board then considered the Order Setting Tax Rate, Approving Tax Roll, and Levying Debt Service and Maintenance and Operation Tax for the Year 2023. It was moved, seconded and unanimously carried that there be passed and adopted the attached Order accepting the final appraisal roll and setting a maintenance and operations rate of \$0.31 per \$100 in taxable valuation and a debt service tax rate of \$0.34 per \$100 in taxable valuation with \$0.025 per \$100 in taxable valuation per road debt and \$0.315 per \$100 in taxable valuation for water, sewer and drainage debt.
- 10. The Board then considered the Amendment to Statement of Directors. Upon duly made, seconded, and unanimously carried, the Board approved the amendment to statement of directors reflected the 2023 tax rate as presented.
- 11. The Board then reviewed a proposal from the District's insurance agent for the renewal of the District's insurance. The Board noted that the renewal package includes a total premium increase of \$5 over the last full term renewal. Upon motion duly made, seconded, and unanimously carried, the Board approved the proposal as presented.
- 12. The Board recognized Mike Crahan who presented the developer's report. Mr. Crahan reviewed recent development activity with the Board.
- 13. The Board then reviewed a drainage maintenance report prepared by Stormwater Solutions. The Board noted the completion of the tree removal.
- 14. The Board then recognized Mr. Robert Atkinson who presented the engineer's report. Mr. Atkinson reviewed the status of ongoing projects with the Board. The engineer is preparing a Bond Application Report to reimburse the developer for the following projects: Willowcreek Ranch Sections 10 & 11, Impact Fees paid to Northwest Harris County MUD No. 5 and North Detention Phases 2 & 3. There were no action items for consideration.

Upon motion duly made and seconded, the Board approved the engineers' report as presented and authorized the action items contained therein.

15. The Board then agreed to hold their next meeting on the regularly scheduled date in December and that a November meeting will not be held unless necessary.

There being no further business to come before the Board, the meeting was adjourned.
