Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
 - a. Phase II MS4 Storm Water Management Plan;
 - b. Interconnect Agreement with Fort Bend County Municipal Utility District No. 30;
 - c. deeds and easements and related environmental assessment proposals, consents to encroachment and encroachment agreements, requests for service, or utility commitment letters;
 - d. water plant maintenance; and
 - e. update on bond application.
8. Attorney's report, including review and update Eminent Domain Report to the Texas Comptroller.
