Minutes of Meeting of Board of Directors

February 13, 2024

The Board of Directors ("Board") of Harris County Water Control and Improvement District No. 113 ("District") met on February 13, 2024, at 14707 Dale Hollow Lane, Cypress, Texas, 77429, pursuant to the duly posted notice of said meeting with a quorum of directors present as follows:

Also in attendance were Mr. Scott Shelnutt of Municipal Operations & Consulting, Inc.; Ms. Michelle Guerrero of Bob Leared Interests; Mr. Christopher T. Burke of Burke Engineering, LLC; and Mr. Douglas McNiel, attorney for the District.

The President called the meeting to order and declared it open for such business as might properly come before it.

1. The Board opened the floor for public comment. Hearing no public comments, the President continued the meeting.

2. The Board considered the minutes of the meeting of January 9, 2024, and upon motion by Director McCorkle, seconded by Director Robicheaux, the Board voted unanimously to approve the minutes as presented.

3. Ms. Michelle Guerrero presented the tax assessor-collector's report reflecting the District's 2022 taxes are 99.30% collected and the District's 2023 taxes are 92.78% collected. She presented four checks for the Board's review and approval and two wire transfers were made. After discussion, upon motion by Director Hoyland, seconded by Director McCorkle, the Board voted unanimously to approve the tax assessor-collector's report.

4. The Board then considered the Order Levying Additional Penalty for Delinquent Taxes. The Board reviewed the penalties for consideration. After discussion, upon motion by Director Hoyland, seconded by Director McCorkle, the Board voted unanimously to approve the Order as presented.

5. The attorney then discussed with the Board the requirements of Texas Local Government Code Chapter 203, Subchapter D (Senate Bill 625). The law requires districts to annually provide certain records and information concerning the District's finances and tax rates to the Texas Comptroller of Public Accounts. The information includes the name of the

District, the names of the Board members, any employees, addresses, websites if applicable, names of certain consultants, the total amount of bonds authorized by District voters, the aggregate principal amount of bonds issued, the tax rate, and audited financial information. After discussion, upon motion by Director Hoyland, seconded by Director Robicheaux, the Board voted unanimously to authorize the attorney to prepare and file the required report by the April 1, 2024 deadline.

6. The Board then considered the Resolution Affirming Identity Theft Prevention Program. The District's operator informed the Board there have been no known incidents of identity theft and no changes are needed to the program at this time. After discussion, upon motion by Director Hoyland, seconded by Director Maniscalco, the Board voted unanimously to approve the Resolution as presented.

7. The Board then considered the Order for Election of Directors. After discussion, upon motion by Director Hoyland, seconded by Director Robicheaux, the Board voted unanimously to approve the Order as presented.

8. Mr. Scott Shelnutt presented the operator's report which reflected 421 total connections in the District. Collections for the month were at \$34,739.54 with current billings at \$31,536.14. The report showed water accountability at 82.76% during the period. Total water plant pumpage for the prior month was 3,180,000 gallons. There were no permit violations reported at the wastewater treatment plant.

Mr. Shelnutt reviewed the status of ongoing and completed projects with the Board. He noted one sanitary sewer line was repaired. Finally, Mr. Shelnutt reviewed the accounts on the District's January delinquent list, which are scheduled for cutoff on February 27, 2024, and Mr. Shelnutt suggested one delinquent account be moved to the District's list of uncollectible accounts. After discussion, upon motion by Director Hoyland, seconded by Director Robicheaux, the Board voted unanimously to approve the operator's report and move the discussed delinquent account onto the District's list of uncollectible accounts.

9. Mr. Chris Burke presented the engineer's report. Upon motion by Director Hoyland, seconded by Director McCorkle, and the Board voted unanimously to approve the engineer's report.

10. The Board then reviewed the bookkeeper's report which reflected the District's operating fund contained \$2,467,150.22, the construction fund contained \$106,241.65, and the bond fund contained \$119,689.38. Upon motion by Director Hoyland, seconded by Director Robicheaux, the Board approved the bookkeeper's report and approved payment of the checks listed thereon.

There being no further business to come before the Board, the meeting was adjourned.
