March 5, 2024

The Board of Directors (“Board”) of Northwest Harris County Municipal Utility District No. 9 (“District”) met at 11203 Regency Green, Cypress, Harris County, Texas in accordance with the duly posted notice of the meeting, with a quorum of directors present as follows:

The President called the meeting to order and declared it open for such business as might properly come before it.

1. The Board recognized Mr. Josh Maas who presented the operator’s report. Mr. Maas reported on the operational activities of the District for the month of February 2024. Mr. Maas also presented a report on write offs of delinquent accounts. The Board voted to send accounts over \$75.00 to collections. The Board also discussed next steps on collections of the water main damages from Ficon Communications. He also reported on a 2011 TCEQ well sampling issue that has since been cleaned up. Upon motion duly made, seconded, and unanimously carried, the Board approved the operator’s report as presented.

2. The Board then recognized Mr. Ronnie Koehn who presented the engineer’s report. He reported that the draft wastewater treatment permit was received from the TCEQ on February 23, 2024. Upon review, it was determined that the draft permit required dechlorination in error. A request to remove the requirement for dechlorination was submitted to the TCEQ on March 5, 2024. Upon motion duly made, seconded, and unanimously carried, the Board approved the engineer’s report as presented.
