Notice is hereby given that the Board of Directors of Harris County Municipal Utility District No. 11 will hold a regular meeting, open to the public, on **WEDNESDAY, 22 MAY 2024, at 5:00 P.M.** at the offices of Coats Rose, P.C., **9 Greenway Plaza, Suite 1000, Houston, Texas**, outside the boundaries of the District. The Board will consider and act upon the following matters:

1. Comments and questions from District residents (five-minute limit for each speaker);

  - (a) report on operations of the District's facilities;
  - (b) status of various repairs or replacement of equipment at District facilities;

  - (f) review and approval annual Drinking Water Quality Report;
4. Engineer's Report, including:
  - (a) discuss condition of the District's water wells;
  - (b) water distribution system;
  - (c) discuss matters relating to Water Supply and Groundwater Reduction Plan Wholesale Agreement (City of Houston);
  - (d) status of outstanding sanitary sewer repairs for Woodgate Subdivision (Lopez Utilities Contractor, LLC);
  - (e) status of requests for service;
  - (f) status of bond application report;
5. Bookkeeper's Report, including:
  - (a) approval of payment of the District's bills;
  - (b) review and approve Investment Report;
6. Old business;
7. New business;

8. Attorney's Report, including:
  - (a) status of Cost Sharing Agreement with Forest Hills Municipal Utility District;
  - (b) status of Utility Commitment, Annexation, Service, Development and Financing Agreement with Werner Enterprises, Inc.;
  - (c) adopt Resolution Authorizing Application to the Texas Commission on Environmental Quality for Approval of Project and Bonds;
9. Convene in executive session pursuant to Texas Government Code, Chapter 551, to discuss matters only relating to pending or contemplated litigation, personnel matters, real estate transactions, or security, if necessary;
