The meeting will be held on Thursday, June 27, 2024, at 6:30 P.M.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

JOINT SEWAGE TREATMENT PLANT COMMITTEE

- A. Consider comments to the Joint Sewage Treatment Plant Committee portion of the May 23, 2024, Board meeting minutes;
- B. Engineering Report:
 - i.
