The Board of Directors of Harris County Municipal Utility District No. 365 will hold a regular meeting on Thursday, June 20, 2024, at 12:00 p.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, **Suite 2400, San Jacinto Room**, Houston, Texas, to discuss and, if appropriate, act upon the following items:

CONSENT AGENDA: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event, the item will be removed and placed on the Regular Agenda.


1. Approve minutes.
2. Financial and bookkeeping matters, including payment of the bills, review of investments.
3. Tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills.
4. Operator's report of District water, sanitary sewer, and stormwater facilities, including billings, repairs and maintenance.

REGULAR AGENDA:

5. Public comment.*
6. Additional bookkeeping matters, including:
 - a. approve Director per diems;
 - b. authorize submittal of joint facilities budget for Harris County Municipal Utility District No. 364; and
 - c. discuss Association of Water Board Directors summer conference, approve reimbursement of eligible expenses, and authorize attendance at winter conference.
7. Review District insurance proposals and authorize renewal of policies.
8. Additional operating matters, including:
 - a. authorize operator to send uncollectable accounts to collection agency;
 - b. customer contact log; and
 - c. review Drought Contingency Plan and Adopt Order Adopting Amended and Restated Drought Contingency Plan, if appropriate.
9. Hearing on termination of water service to delinquent customers and authorize termination of service.
10. Additional tax assessment and collection matters, including:
 - a. review delinquent tax roll and write off accounts, as appropriate; and

- b. authorize delinquent tax attorney to proceed with collection of delinquent taxes.
- 11. Update on Harris County Municipal Utility District No. 364 trail modifications project and approve related maintenance agreement.
- 12. Recreational and landscape matters, including:
 - a. approve pay estimates, change orders, and final acceptance, as appropriate;
 - b. trail, detention and common area maintenance, signage, water fountains, and interactive fountain;
 - c. fencing repairs and replacement; and
 - d. tree installation, maintenance, and removal.
- 13. Engineering matters, including:
 - a. utility availability requests;
 - b. design, plan approval, advertisement for bids, contract award, approval of pay estimates and change orders, materials and field testing, permitting, storm water quality management plans, storm water pollution prevention plans, and other necessary actions relating to facilities, including:
 - i. joint channel and drainage repairs; and
 - ii. smart meters;
 - c. feasibility study regarding potential water plant control system improvements;
 - d. deeds, easements, and encroachments;
 - e. annual review of capital improvement plan;
 - f. consider conveyance of lift station no. 2 site to the District and take appropriate action; and
 - g. other engineering matters.
- 14. Water conservation and drainage matters, including federal grant funds potentially available for District drainage projects, associated costs, timeline for implementation, and related matters.
- 15. Communication matters, including report from Communications Committee, updates to District website, and take appropriate action.
- 16. Update on donation to Sampson Elementary School for playground equipment and related Interlocal Agreement with Cy-Fair Independent School District.
- 17. Review District committee assignments and take appropriate action.
- 18. Discuss July 2024 meeting schedule and future agenda items.

Engaging in verbal attacks or comments intended to insult, abuse, malign, or slander any individual shall be cause for termination of time privileges.

Harris County Municipal Utility District No. 365 reserves the right to adjourn into executive session at any time during the course of this meeting to discuss any of the matters listed above, as authorized by the Texas Open Meetings Act, Texas Government Code §§ 551.071 (Consultation with Attorney), 551.072 (Deliberations about Real Property), 551.073 (Deliberations about Gifts and Donations), 551.074 (Personnel Matters), 551.076 (Deliberation about Security Devices), and any other provision under Texas law that permits a governmental body to discuss a matter in a closed executive session.
