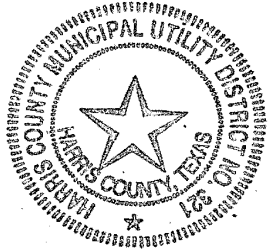
HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 321

The Board of Directors of Harris County Municipal Utility District No. 321 will hold a regular meeting on Tuesday, June 18, 2024, at 11:00 a.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Trinity Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes of prior meetings.
3. Financial and bookkeeping matters, including payment of the bills, review of investments, depository pledge agreements, and amendment of budget, if necessary.
4. Tax assessment and collections matters, including payment of tax bills, installment agreements, delinquent tax collections, depository pledge agreements, and requests for estimates of taxable value.
5. Operation of District facilities, including billings, repairs, maintenance, update on lead service line inventory, and amendment of Rate Order, if appropriate.
6. Hearing on termination of water and sewer service to delinquent customers and for damages or theft of District facilities or services and authorize termination of service.
7. City of Houston industrial user permitting matters.
8. Maintenance of detention ponds and District facility sites, including proposals for additional work.
9. Development matters.
10. Discussion of proposed annexation of land into the District, including approve annexation agreement and authorize engineer to prepare feasibility study.
11. Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
 - a. water well no. 3 driveway;
 - b. water well no. 3;
 - c. water well no. 3 water line extension;
 - d. next phase of District facilities;
 - e. capital improvement plan;
 - f. water plant no. 1 rehabilitation to GST No. 1 and 2 and HPT no. 1 and 2;
 - g. proposals for engineering services; and
