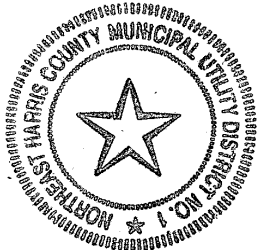
NORTHEAST HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 1

The Board of Directors of Northeast Harris County Municipal Utility District No. 1 will hold a regular meeting on Monday, August 5, 2024, at 11:30 a.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2600, Brazos Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Receive public comments.
2. Approve minutes.
3. Review and approve final developer reimbursement report for Series 2024 Unlimited Tax Bonds and authorize disbursement of bond proceeds.
4. Financial and bookkeeping matters, including payment of bills, review of investments and invoices, and amend budget.
5. Renewal of District's insurance policies.
6. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
7. Adopt Resolution Regarding Development Status for 2024 Tax Year.

 - iii. Edgewood Village, Section 11;
 - iv. Sheldon Ridge, Section 13; and
 - v. Sheldon Ridge Lift Station;
 - c. review bids and award contracts, and authorize execution of letter financing agreements:
 - i. Edgewood Village, Section 10;
 - d. approve pay estimates, change orders, and final acceptance as appropriate, for the following construction projects:
 - i. Wastewater Treatment Plant Expansion;
 - ii. Sheldon Ridge Park;
 - iii. Sheldon Ridge, Section 12; and
 - iv. Sheldon Ridge, Section 14;
