NOTICE OF VOTE ON TAX RATE

If the district adopts a combined debt service, operation and maintenance, and contract tax rate that would result in the taxes on the average residence homestead increasing by more than 3.5 percent, an election must be held to determine whether to approve the operation and maintenance tax rate under Section 49.23602, Water Code. An election is not required if the adopted tax rate is less than or equal to the voter-approval tax rate. The voter-approval tax rate is \$.70498 and therefore, notwithstanding the above, no election is required.

The 86th Texas Legislature modified the manner in which the voterapproval tax rate is calculated to limit the rate of growth of property taxes in the state.
