1. Public comments.

3. Financial and bookkeeping matters, including payment of the bills, review of investments, depository pledge agreements, and amendment of budget, if necessary.
4. Tax assessment and collections matters, including payment of tax bills, installment agreements, delinquent tax collections, depository pledge agreements, and requests for estimates of taxable value.
5. Conduct public hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form.
6. Operation of District facilities, including presentation from the operator, billings, repairs, maintenance, update on lead service line inventory, proposals for certain improvements, and amendment of Rate Order, if appropriate.
7. Hearing on termination of water and sewer service to delinquent customers and for damages or theft of District facilities or services and authorize termination of service.
8. City of Houston industrial user permitting matters.
9. Maintenance of detention ponds and District facility sites, including proposals for additional work.
10. Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
 - a. water well no. 3 water line extension;
 - b. water plant no. 1 rehabilitation to GST No. 1 and 2 and HPT no. 1 and 2;
 - c. water well no. 3;
 - d. next phase of District facilities;
 - e. capital improvement plan;
 - f. proposals for engineering services; and
