The Board of Directors of Mission Bend Municipal Utility District No. 2 will hold a regular meeting on **Tuesday, October 15, 2024, at 6:00 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, in the Guadalupe Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes of prior meetings, including, September 17 (Regular), October 1 (Greenbelt), October 8 (Special), and October 14 (Chelford).
3. Security services matters, including:
 - a. report from Harris County Sheriff's Office; and
 - b. update on the implementation of signs prohibiting commercial vehicles from parking overnight.
4. Park maintenance matters, including authorize proposals.
5. Discuss irrigation system matters, including authorize proposals.
6. Lighting maintenance and repair, including authorize proposals.
