Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas, said address being a meeting place of the District.

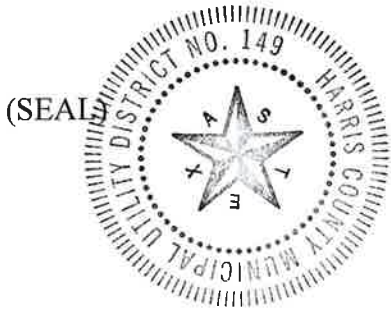
The meeting will be held on **Monday, October 21, 2024, at 1:30 p.m.**

The Board shall consider and discuss the following matters and take any action necessary or appropriate with respect to such matters:


1. Public Comments;
2. Review and approve the minutes of the September 16, 2024, Board meeting;
3. Acceptance of Resignation of Director VanDyke effective November 1, 2024;
4. Status of the District's bond application report in connection with the District's \$11,230,000 Unlimited Tax Bond, Series 2024 ("Bonds"), including review of Order of the Texas Commission of Environmental Quality authorizing issuance of same, and take the following actions related to the Bonds:
 - a) Review and approve Preliminary Official Statement and Official Notice of Sale;
 - b) Authorize the District's financial advisor to advertise for the sale of the Bonds;
 - c) Approval of designation Paying Agent/Registrar; and
 - d) Authorize Bookkeeper to issue check for Attorney General's fees;
5. Conduct a public hearing regarding the adoption of the District's 2024 tax rate;
6. Levy of the District's 2024 debt service and maintenance tax rates, and the adoption of an Order in connection therewith;
7. Approval and execution of an Amended District Information Form;
8. Tax Assessor-Collector report, including authorizing payment of invoices presented and approve moving of accounts to uncollectible roll;
9. Report and legal action taken by the District's delinquent tax collections attorney, including:
 - a) Appeals of termination of water service for delinquent tax accounts; and the taking of any action in connection therewith, including authorizing water termination, foreclosure proceedings, installment agreements, and the filing of proofs of claim;
10. Bookkeeper's Report, including payment of invoices presented;

11. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting;
12. Annual review of Amended Order Establishing Policy for Investment of District Funds and Appointing Investment Officer, and adoption of Resolution in connection therewith;
13. Trash and recycling services provided by Texas Pride;
14. Operations and Maintenance report, including:
 - a) Authorize repairs and maintenance of District facilities, and authorize acceptance of TEC Form 1295, as applicable, including:
 1. Status of water distribution system valve repairs;
 - b) Appeals of District charges;
 - c) Referral of accounts for collection and approve write-off of uncollectible accounts;
 - d) Communications with customers, including mass messaging;
15. Engineering report, including:
 - a) Authorizing the design and/or advertisement for bids for the construction of facilities within the District, including:
 1. Status of design of new Water Plant Project;
 2. Rehabilitation of digesters at Wastewater Treatment Plant;
 - b) Authorize the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, and authorize acceptance of TEC Form 1295, as applicable, and approval of any related stormwater permits;
 - c) Status of construction of facilities to serve land within the District, including the approval of any change orders, and authorize acceptance of TEC Form 1295, as applicable:
 1. Sanitary Sewer Rehabilitation Project (Insituform Technologies, Inc.);
 - d) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and authorize acceptance of TEC Form 1295, as applicable, including:
 1. Water Line Easement from Tracy Pham;
 - e) Capital Improvement Plan;
 - f) Requests for Utility Commitments;
16. Report from Champions Hydro-Lawn, Inc., including maintenance of detention facilities for the 4.66 acres Barker Cypress/FM 529, L.P. tract, the sites of the Wastewater Treatment Plant, Water Plant, and Off-Site Lift Station, and the Harris County Flood Control District channel;
17. Discussion regarding surface water issues relative to the West Harris County Regional Water Authority;
18. Attorney's Report, including:
 - a) Status of litigation among Harris County Municipal Utility District No. 257, Si Environmental, LLC and the District regarding reported usage amounts related to expenses to operate and maintain joint Water Plant and joint Wastewater Treatment Plant (Cause No. 2022-79830; 61st District Court, Harris County, Texas); and

- b) Approval and execution of representation letter prepared for McCall Gibson Swedlund Barfoot, PLLC;
