


NOTICE OF MEETING

MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO. 186

The Board of Directors (“Board”) of Montgomery County Municipal Utility District No. 186 (“District”) will hold a regular meeting, open to the public, on **Monday, October 14, 2024, at 1:00 p.m., at Pape-Dawson Engineers, Inc., 2107 CityWest, 3rd Floor, Houston, Texas 77042**, to discuss and, if appropriate, act upon the following:

1. Public comments.
2. Minutes.
3. Bookkeeping matters, including payment of the bills.
4. 2024 Contract Tax Rate.
5. Contract Revenue Bonds (Water, Sewer, and Drainage Facilities), Series 2024A, including:
 - a. appointment of Paying Agent/Registrar;
 - b. Preliminary Official Statement and Official Notice of Sale; and
 - c. authorization for developer reimbursement report.
6. Engineer’s report, including:
 - a. authorization to design facilities and approval of contracts for design of construction projects in the District;
 - b. approval of plans and specifications and authorization to advertise for bids for construction projects in the District;
 - c. review of bids and award of contracts and authorization to execute letter financing agreements for construction projects in the District, including:
 - i. The Highlands Detention, Phase 1B-4;
 - ii. water, sewer, and drainage improvements for Mirror Lake Circle, Phase 5;
 - iii. paving improvements for The Highlands Parkway North, Phase 1; and
 - iv. force main for lift station no. 3.
 - d. approval of pay estimates, change orders, and final acceptance as appropriate, for construction projects in the District, including:
 - i. water, sewer, and drainage improvements for Mirror Lake Circle, Phase 3;
 - ii. The Highlands Detention Phase 1B-2 (Shelf Expansion and Repairs);
 - iii. Highlands TxDOT ROW Ditch;
 - iv. clearing of The Highlands Detention, Phase 1B-4;
 - v. clearing of The Highlands middle school; and
 - vi. guardrail for The Highlands TxDOT ditch.
 - e. permits, deeds, easements, consents to encroachment, and utility commitment letters;
 - f. report on internal district projects; and
 - g. authorization to execute documentation related to National Finance Authority Special Revenue Bonds (The Highlands Montgomery County Municipal Utility Districts Projects), Series 2024.
7. Agreement for maintenance of District facilities, including correspondence to Montgomery County.
8. Landscaping matters, including:
 - a. authorization to design facilities and approval of landscaping proposals for design of construction projects in the District;
 - b. approval of plans and specifications, and authorization of advertisement for bids for construction of projects in the services area, including:

- i. Model Home, Phase 2 – hardscape improvements;
 - ii. Model Home, Phase 2 – softscape improvements;
 - iii. The Highlands, Lake 3 – hardscape improvements;
 - iv. The Highlands, Lake 3 – softscape improvements;
 - v. Mirror Lake Circle, Phase 4 (Part 1, near Section 13) – hardscape improvements; and
 - vi. Mirror Lake Circle, Phase 4 (Part 1, near Section 13) – softscape improvements.
 - c. review of bids, award of contracts, and execution of Letter Financing Agreement for projects in the service area, including:
 - i. The Highlands, Section 12 - hardscape improvements.
 - d. approval of pay estimates, change orders, and final acceptance, as appropriate, for projects in the service area, including:
 - i. The Highlands, Phase 2 Cumberland landscape improvements;
 - ii. The Highlands, Lake 2 – hardscape improvements;
 - iii. Mirror Lake Circle, Phase 2 (East) – hardscape improvements (including retaining wall);
 - iv. Mirror Lake Circle, Phase 2 (East) – landscape (softscape) improvements;
 - v. Mirror Lake Circle, Phase 3 – hardscape improvements;
 - vi. The Highlands, Lake 2, Phase 1 landscape improvements; and
 - vii. Mirror Lake Circle, Phase 3 (East) – landscape (softscape) improvements.
9. Operation of District facilities, including:
 - a. billing, repairs, and maintenance; and
 - b. hearing on termination of water and sewer service to delinquent customers from Montgomery County Municipal Utility District No. 140 and termination of services.
10. Report on development in the District.
11. Next meeting date.
