1. The most recent rate of taxes levied by the District on all property within the District is \$0.395 on each \$100 assessed valuation, comprised of debt service levy of \$0.14.5 per \$100 of assessed valuation and maintenance tax levy of \$0.25 per \$100 of assessed valuation.

2. The form Notice to Purchasers required by §49.452, Texas Water Code, as amended, to be furnished by a seller to a purchaser of real property in the District is attached hereto as **Exhibit "A"** and incorporated herein for all purposes.

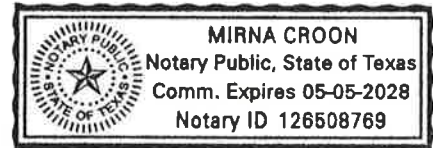

The real property that you are about purchase is located in **KINGSBRIDGE MUNICIPAL UTILITY DISTRICT** (the "District") and may be subject to district taxes or assessments. The district may, subject to voter approval, impose taxes and issue bonds. The district may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is \$0.395 on each \$100 assessed valuation, comprised of debt service levy of \$0.14.5 per \$100 of assessed valuation and maintenance tax levy of \$0.25 per \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters, approved by the voters are:

\$66,255,000 for water, sewer, and drainage facilities

The aggregate initial principal of all such bonds issues are:

\$41,775,000 for water, sewer, and drainage facilities

The District is located wholly or partly in the extraterritorial jurisdiction of the City of Houston. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved.

The District has entered into a strategic partnership agreement with the City of Houston. This agreement may address the timeframe, process, and procedures for the municipal annexation of the area of the District located in the municipality's extraterritorial jurisdiction.

The purpose of the District is to provide water, sewer, drainage, flood control, parks and recreational, and flood control facilities and services. The cost of district facilities is not included in the purchase price of your property.
