

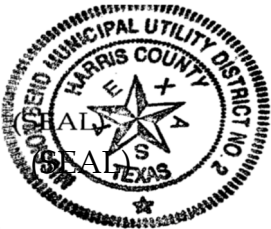
NOTICE OF MEETING

MISSION BEND MUNICIPAL UTILITY DISTRICT NO. 2

The Board of Directors of Mission Bend Municipal Utility District No. 2 will hold a regular meeting on **Tuesday, December 17, 2024, at 6:00 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, in the Guadalupe Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes of prior meetings, including, November 19 (Regular), December 3 (Greenbelt), and December 10 (Chelford), 2024.
3. Security services matters, including:
 - a. report from Harris County Sheriff's Office; and
 - b. update on the implementation of signs prohibiting commercial vehicles from parking overnight.
4. Park maintenance matters, including authorize proposals.
5. Lighting maintenance and repair, including authorize proposals.
6. District surveillance camera matters, including authorize proposals.
7. Financial and bookkeeping matters, including payment of the bills and review of investments.
8. Travel reimbursement guidelines and Director expenses for the Association of Water Board Directors winter conference.
9. Tax assessment and collections matters, including:
 - a. delinquent tax collections, installment agreements, and payment of tax bills; and
 - b. Amended Agreement for Services of Tax Assessor/Collector.
10. Chelford City Regional Wastewater Treatment Plant matters, including sale of surplus capacity.
11. West Harris County Regional Water Authority matters.
12. Operation of District facilities, billings, repairs and maintenance, and related operating matters, including the following:

 - b. update on televising of facilities in Altamira, Section 1;
 - c. update on automated meter trial program;
 - d. Mission Bend Integrated Water System operating matters; and
 - e. authorize assessment of penalties for Rate Order violations.
13. Engineering matters, including proposals, agreements and amendments related thereto, pay estimates, change orders, and final acceptance, if appropriate, for the following:
 - a. permanent generator project;
 - b. sanitary sewer cleaning and televising project;
 - c. water plant no. 1 ground storage tank rehabilitation;

- d. storm water quality inspections and permitting for Terra del Sol, Section 8; and
 - e. requests for service or utility commitment letters.
14. Park and recreational facility matters, including proposals, agreements and amendments related thereto, pay estimates, change orders, and final acceptance, if appropriate, for the following:
- a. Magnolia Park maintenance, including:
 - i. Phase III improvements;
 - ii. park access options; and
 - iii. storm debris damage and brick fence repair.
 - b. Mission Bend Greenbelt Trail improvements project, including:
 - i. west side Trail expansion project; and
 - ii. Trail lighting project.
 - c. Little Villa Wetland improvement project, including:
 - i. Phase II improvements.
 - d. Pressure washing in the District; and
 - e. Median improvements.
15. Harris County Precinct No. 4 matters, including:
- a. Places for People: 2023 Interlocal Agreements and Project Updates; and
 - b. Inventory and Interlocal Agreement for Public Infrastructure Maintenance.
16. Review and update Eminent Domain Report to the Texas Comptroller.
17. District technology and communications matters, including authorize service proposals, if appropriate.
18. Meeting schedule and planning matters.
