The real property that you are about to purchase is located in Harris County Municipal Utility District No. 105 **Defined Area**, may be subject to a higher tax than other land within the **District**, and may be subject to district taxes or assessments. The **Defined Area** has taxing authority separate from any other taxing authority, and may, subject to voter approval, impose taxes and issue bonds. The district may impose an unlimited rate of tax in payment of such bonds.

The current rate of the **Defined Area** property tax is \$0.00 on each \$100 assessed valuation (not including any taxes levied for the benefit of the District). This tax rate is in addition to the tax rate levied by Harris County Municipal Utility District No. 105 throughout the District.

The total amount of bonds of **Defined Area** payable wholly or partly from property taxes in **Defined Area**, excluding refunding bonds that are separately approved by the voters and excluding any bonds or any portions of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by voters are:

\$6,400,000 for water, sewer, and drainage facilities;

\$5,000,000 for road facilities; and

\$1,000,000 for parks and recreational facilities.

The aggregate initial principal amounts of all such bonds issued are:

\$0.00 for water, sewer, and drainage facilities;

\$0.00 for road facilities; and

\$0.00 for parks and recreational facilities.

The **Defined Area** is located wholly or partly in the extraterritorial jurisdiction of the City of Houston. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved.

The district has entered into a strategic partnership agreement with the City of Houston, Texas. This agreement may address the timeframe, process, and procedures for the municipal annexation of the area of the district located in the municipality's extraterritorial jurisdiction.

The purpose of the **Defined Area** is to provide water, sewer, drainage, flood control, roads, parks and recreational, or other types of facilities and services. The cost of district facilities is not included in the purchase price of your property.
