Director Frost attended the meeting by videoconference. Mr. Young noted that Director Frost would be counted as present for this meeting and that he could participate in the discussions and vote on matters before the Board at this meeting, pursuant to Texas Government Code §551.127.

Also present were J. Ron Young of Young & Brooks, Dana Davis of Myrtle Cruz, Inc., Lina Loaiza of Bob Leared Interests, Greg Dubiel of Municipal Operations and Consulting, Jack Miller of R.G. Miller Engineers, Inc., and the residents on the attached sheet.

The president called the meeting to order and declared it open for such business as may come before the Board.
