Minutes of Meeting of Board of Directors November 11, 2024

The Board of Directors ("Board") of Harris County Municipal Utility District No. 216 ("District") met at 2727 Allen Parkway, Suite 1100, Houston, Harris County, Texas, on November 11, 2024, in accordance with the duly posted notice of the meeting, with a quorum of directors present as follows:

Also present were Mr. Bob Ideus of Municipal Business Services, Inc.; Ms. Melissa Vasquez of Forvis Mazars, LLP; Ms. Michelle Guerrero of Bob Leared Interests; Mr. Mark Ivy of Marlon Ivy & Associates; Mr. Ronnie Koehn of Koehn & Associates Engineers, Inc.; and Mr. James D. Bonham, attorney for the District.

The meeting was called to order and declared open for such business as might properly come before it.

- 1. The Board considered the minutes of the meeting held October 14, 2024, and upon motion duly made, seconded, and unanimously carried, the Board approved the minutes as presented.
- 2. The Board then recognized Mr. Bob Ideus who presented the bookkeeper's report. The Board reviewed invoices presented by the bookkeeper and reviewed a schedule of District investments. The Board also reviewed the General Fund budget for the fiscal year ending June 30, 2025. After review and discussion, upon unanimous vote, the Board approved the bookkeeper's report and the checks listed thereon.
- 1. The Board recognized Ms. Melissa Vasquez of Forvis Mazars, LLP and reviewed the audit report for the fiscal year ended June 30, 2024 including the Management Discussion and Analysis and a Management Letter. After review and discussion, upon unanimous vote, the Board approved the audit report and the audit filing affidavit and authorized filing as required by law.
- 3. The Board then reviewed the tax assessor/collector's report reflecting the District's 2023 taxes to be 99.99% collected. The Board reviewed a schedule of delinquent taxes, and after discussion, upon motion duly made, seconded, and unanimously carried, the Board approved the tax assessor/collector's report and the checks drawn on the tax account.

- 4. Mr. Mark Ivy then presented the operator's report reflecting 143 total accounts in the District. The Board reviewed the operation of the water plant and the sewer treatment plant. Mr. Ivy reported that 91.39% of the water pumped during the previous month had been accounted for and reported no waste discharge permit violations. Mr. Ivy also reviewed with the Board the repairs and maintenance to the District's facilities during the previous month. After discussion by the Board, upon unanimous vote, the Board approved the operator's report and authorized termination of water service to all customers on the delinquent account list in accordance with the District's Rate Order.
- 5. Mr. Ronnie Koehn then presented the engineer's report. Mr. Koehn reported on each item which appears in the report including the requests for utility capacity to serve 16 lots on Kingsland Boulevard. After review and discussion, upon unanimous vote, the Board approved the engineer's report.
- 6. The Board then reviewed proposals for renewal of the District's insurance coverage, and after review of the coverage and premiums, upon unanimous vote, the proposals were accepted as presented.

There being no further business to come before the Board, the meeting was adjourned.
