The Board of Directors of Mission Bend Municipal Utility District No. 2 will hold a regular meeting on **Tuesday, January 21, 2025, at 6:00 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, in the Guadalupe Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes of prior meetings, including, December 17 (Regular), 2024, and January 7 (Greenbelt), and January 13 (Chelford), 2025.
3. Security services matters, including:
 - a. report from Harris County Sheriff's Office; and
 - b. update on the implementation of signs prohibiting commercial vehicles from parking overnight.
4. Park maintenance matters, including authorize proposals.
5. Lighting maintenance and repair, including authorize proposals.

 - ii. Trail lighting project;
 - c. Little Villa Wetland improvement project, including:
 - i. Phase II improvements.;
 - d. pressure washing in the District; and
 - e. median improvements.

- a. Places for People Project Updates; and
 - b. Inventory and Interlocal Agreement for Public Infrastructure Maintenance.
19. District technology and communications matters, including authorize service proposals.
