The meeting will be held on Wednesday, June 25, 2025, at 11:00 A.M.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

 - a) Status of Utility Commitment to Logistics Property Company, LLC for water and sanitary sewer service to serve proposed CityPark Logistics Center Buildings 5 and 6; authorize any action necessary in connection therewith;
